## PA COVID-19 Relief Statewide Small Business Assistance program FAQ's

## **Preliminary fact sheet**

Administered by 17 CDFI's (Community Development Funding Institutions): non-profit, non-governmental "do-gooder" lenders. Do NOT do grants other than this one (first ever). You'll apply online with a common app but you need to know which CDFI serves you as an ongoing relationship will be established to assist your business. Find the CDFI that serves your area <a href="here.">here.</a> Once you determine you may quailify and want to apply, contact your CDFI.

**\$200M** statewide; ½ designated for historically disadvantaged (people of color). ½ designated for Main Street and Elm Street communities. Trail Towns (such as those near the GAP Trail) and businesses in the PA Wilds designated communities also priority. Women-owned and rural also give applicants advantage. Veteran owned has not been considered for this grant.

To be eligible to apply, a business must meet **all three** of the eligibility requirements: 1. Be physically located, certified to do business, and generate at least 51% of their revenues in PA; 2. Have annual revenue of \$1 million or less before the effects of the Pandemic; 3. Have 25 or fewer full-time equivalent employees prior to February 15, 2020.

Sole Proprietors can apply but must have a local business license or DBA

Applications will open **June 30 for 10 days** (hopefully). Once first round is funded, additional rounds will be announced. NOT a first come, first served opportunity. If not funded in one round you don't need to re-apply.

**Award amounts** Businesses are eligible based on their annual revenues as documented in their most recent tax return.

\$75,001 to \$100,000	\$15,000
\$100,001 to \$250,000	\$20,000
\$250,001 to \$500,000	\$25,000

\$750,001 to \$850,000	\$40,000
\$850,001 to \$1,000,000	\$50,000

## Items needed to apply:

- 1. Government Issued Photo ID (such as a Driver's License or Passport)
- 2. Business financial information
  - Revenue from March 1st to May 31st for 2019 and 2020
  - Most recently submitted Federal Tax Return. 2018 or 2019 business and personal tax returns including Schedule C
  - If startup between January 1-February 15, 2020, Internal Profit & Loss Statement
- 3. Proof of Business Registration with PA Department of State (as applicable)
  - Articles of Incorporation (for corporations and LLCs)
  - Fictitious Name Registration or "Doing Business As" (for sole proprietors)
  - or Business License (if applicable)
- 4. Bank Account Information
